MERGER OF TWO 70% SUBSIDIARIES DISSOLUTION OF A 70% SUBSIDIARY AND CHANGE IN DIRECTORS' INFORMATION

Reference is made to the announcement (“**Announcement**”) of Kaisun Energy Group Limited (“**Company**”) dated 6 September 2010 and 26 August 2010 in relation, among others, the merger of 鄂爾多斯市啟杰蒙西煤化有限公司 (Ordos GEM Coal & Chemical Co., Ltd.) (“**Mengxi Chemical**”) and 內蒙古蒙西礦業有限公司 (Inner Mongolia Mengxi Minerals Co., Ltd.) (“**Mengxi Minerals**”), each a 70% subsidiary of the Company. Capitalised terms used herein shall have the same meanings as those defined in the Announcement unless the context requires otherwise.

DISSOLUTION OF MENGXI CHEMICAL AND CHANGE IN DIRECTORS' INFORMATION

Mengxi Chemical was dissolved on 12 September 2010 upon completion of the necessary filings and obtaining of the relevant approvals in the PRC.

As stated in the Announcement, Mr. Chan Nap Kee Joseph, Mr. Yang Yongcheng are also directors of Mengxi Chemical. Mr. Li Hong, who was appointed as a director of the Company with effect from 3 September 2010, is also a director of Mengxi Chemical. To comply with Rule 17.50A(2) of the GEM Listing Rules, this announcement is made by the Company reporting the change in information required to be disclosed by Mr. Chan Nap Kee Joseph, Mr. Yang Yongcheng and Mr. Li Hong pursuant to Rule 17.50(2)(1) of the GEM Listing Rules. Mr. Chan Nap Kee Joseph, Mr. Yang Yongcheng and Mr. Li Hong were no longer directors of Mengxi Chemical as from 12 September 2010, the date of dissolution of Mengxi Chemical.
