Kaisun Energy Group signs Letter of Intent with Xinjiang Coal Bureau, with intention to jointly develop coal mines in Tajikistan

The board (the "Board") of the directors (the "Directors") of Kaisun Energy Group Limited ("Kaisun Energy") is pleased to announce that on 14 November, 2011, our Company and Xinjiang Uygur Autonomous Region Coal Geology Bureau ("Xinjiang Coal Bureau")(新彊維吾爾自治區煤田地質局) have entered into a Letter of Intent (the "Cooperation Agreement") pursuant to which the parties, will cooperate with each other to carry out exploration, exploitation, etc. of coal mines in Tajikistan.

Xinjiang Coal Bureau agreed during preliminary period to send its technical experts to the three mines owned bv Saddleback Mining Limited ("Saddleback"), which is wholly owned by Kaisun Energy, to conduct site visit, take samples and draft exploration program, which provide the basis of the geological exploration of the mines in Tajikistan for the future.

Xinjiang Coal Bureau intends to jointly develop Saddleback's

mines. Xinjiang Coal Bureau can own equity interest in Saddleback by providing cash, exploration services or plant and machinery in return.

Leveraging Kaisun's proven operating model and Xinjiang Coal Bureau's expertise in exploration, both parties will cooperate to explore and develop mining resources.

Mr. Joseph Chan Nap Kee, Chairman of Kaisun Energy, said, "The technical team of Xinjiang Coal Bureau have worked on a large amount of coal geology projects and amassed wide geological information and geological exploration results, and brings to the table over 55 years of mining history in the region. This joint development will accelerate our coal extraction in the mines, and strengthen our competencies in the Tajikistan project regarding our overall capabilities in terms of technical expertise, equipments and professional's contribution."

"During the meeting between Chinese Premier Wen Jiabao with Tajikistan Prime Minister Akil Akilov attending the 10th Meeting of the Prime Minister of the Member States of the Shanghai Cooperation Organization (SCO), in Russia on Nov 7, 2011, Wen highly valued the mutual cooperation between the two countries, saying that it has brought real benefits to the two peoples. Akilov hailed the mutually beneficial cooperation, stressing that to develop relations with China has been always a priority of Tajik foreign policy. Tajikistan is willing to closely coordinate with China to implement consensus reached by the two countries' leaders in a bid to bring more benefits to the two peoples."
